- In any amount consistent with agency policies
- Below \$22 million without a J&A per Section 811
- Up to \$100 million for DoD contracts per the NDAA for FY2020
- Sole-source awards to tribally owned businesses cannot be protested [13 CFR 124.517(a)]

TRIBALLY-OWNED BUSINESSES

- Can have direct negotiations with the government
- Are always considered Small Disadvantaged Businesses (SDBs)
